Does my gift stay in my community?

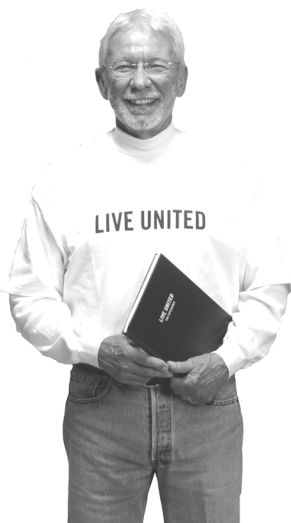
