We have had some challenges with our transition to a new accounting and database management system that has consumed far more time and energy than originally planned.

Reading Tutors Report for School Year 2012 - 2013

United Way of Southeast Alaska is pleased to report on the strategic partnership with Coeur Alaska and the Juneau School District to help ensure all Juneau students are reading at grade level by third grade. Coeur Alaska has committed to investing a generous \$75,000 over a three year time frame toward the education and future success of children by sponsoring the Learn United: Reading Tutor Program. This partnership sets the gold standard for real, meaningful volunteer work in our schools.

The LEARN UNITED: Reading Tutor Program identifies students in need of reading skill building, solicits and engages volunteers to serve as reading tutors, and provides training and recognition for the tutors. It gives community members a way to genuinely impact the lives of our students and families.

To find the right people to help support language and literacy skills in schools, the United Way of Southeast Alaska utilizes its "Get Connected" community engagement and online volunteer management tool. Our SAGA AmeriCorps volunteer developed a reading tutor recruitment posting that paired community volunteers with elementary students in an effort to improve literacy skills by third grade. Once the volunteer engagement portal was developed, advertising was placed in the newspaper, posts were developed for social media, and post cards and flyers were strategically placed throughout the community. United Way staff, school district personnel and Coeur Alaska staff joined in a joint announcement and presentation at the Juneau Chamber weekly meeting on September 13, 2012. Copies of the various materials used to promote the program and the ensuing publicity received are included with this report as attachments.

Once volunteers have been selected and have completed a mandatory background check, the Juneau School District trained volunteers with skills and materials as well as matched them with children who could benefit the most from the volunteer's time and caring attention. The team is committed to helping all students read at grade level by the completion of the third grade and the Reading Tutor program holds great promise to deliver on this goal.

Learn United: Reading Tutors program ran exceptionally well for the first year. We look forward to building upon the first year's success in year two.

Program Narrative:

The Reading Tutor Program began working with students in late October at Riverbend Elementary. During the fall semester, we had 8 tutors who worked one on one with a student twice a week for 30 minutes. During the spring semester, we had 12 tutors meeting the same levels of participation. Two children made significant progress and were moved out of the tutor program earlier than expected as they reached grade level skill. Two additional students were moved into those slots. Overall, we assisted almost 25 students with increasing their reading skills and abilities.

Students are tested in the fall and spring utilizing the Dynamic Indicators of Basic Early Literacy Skills (DIBELS) Assessment. The DIBELS are a set of procedures and measures used to identify children experiencing difficulty in acquisition of basic early literacy skills in order to provide support early and prevent the occurrence of later reading difficulties. Comprised of seven measures to function as indicators of phonemic awareness, alphabetic principle, accuracy and fluency with connected text, reading comprehension, and vocabulary, DIBELS are designed to be short (one minute) fluency measures used to regularly monitor the development of early literacy and early reading skills.

All students showed marked improvement as a result of their one on one assistance and tutoring. A copy of their aggregated test results is included as an attachment to this report.

Children received incentives (pencils and stickers) with which to record their reading progress. Once their reading chart was complete, they earned books and a book bag as incentives to continue their reading progress.

Background Checks:

When volunteering with the Juneau School District, all volunteers were required to complete a volunteer screening process including a background check that is provided at no cost to the volunteer.

The background check looked for criminal history. If the background check was clear, the volunteer's name was forwarded to the school/principal/parent volunteer coordinator. If the background check revealed past criminal history, the volunteer was asked by Human Resources to clarify the information prior to being cleared to work individually with students.

Training:

Reading Coach Kelly Harvey provided training to over 20 reading tutor volunteers in mid-October. Kelly presented an overview of the program, explained the processes and requirements of the program and had the tutors review and practice with each other in preparation of being assigned a student with whom the tutor would work. Tutors, who were not at the initial reading tutor training, received one on one training from the Juneau School District reading coach.

Program:

The program was aligned with what was going on in the classroom instructional program and it included the following components:

1. Phonemic Awareness Word Work - Phonemic awareness is the ability to hear, identify, and manipulate individual sounds-phonemes--in spoken words. Before children learn to read print, they need to become more aware of how the sounds in words work. They must understand that words are made up of speech sounds, or phonemes (the smallest parts of sound in a spoken word that make a difference in a word's meaning).

Phonemic Awareness is developed through activities that help students:

- Identify and categorize sounds
- Blend sounds to form words
- Delete or add sounds to form new words
- Substitute sounds to make new words

2. Phonics Practice - This involves practice with letter recognition, letter sound practice and blending words.

3. Sight Word Practice - This is a basic word recognition task. Students have sight word rings. Rings are practiced to commit words to memory.

4. Read - The child reads decodable books from their book box out loud to the tutor to assist in reading fluency. Child should track words as he/she reads aloud.

Communication:

The reading coach provided occasional email updates to tutors, provided feedback to teachers on progress being made with the individual students, reviewed the students testing to track improvements and reported to tutors on potential areas that may have needed additional practice.

Appreciation:

December: At the end of the fall semester, Reading Coach Kelly Harvey sent each of the tutors a seasonal card and a small recognition gift.

May: At the end of the spring semester, all tutors were recognized at a luncheon. United Way and Coeur Alaska staff, students, teachers, and tutors all gathered for lunch at Riverbend Elementary School. Students presented a small gift of recognition and appreciation to the tutor for their work and support throughout the school year.

Feedback:

The feedback we received from tutors and teachers alike was very positive!! We are happy to report that things went smoothly for the pilot year. The tutors were committed and the students enjoyed time with their reader buddies. A copy of survey results and a mid-term report from Reading Coach Kelly Harvey is included as an attachment with this report.

Budget:

The Coeur Alaska grant of \$25,000.00 was more than sufficient to meet the needs of the first year's effort. United Way expended \$5,805.27 in the first year of the pilot program. This first year was less capital intensive than anticipated as we did not get the program rolled out in more schools the first year. A copy of the budget is attached with this report outlining expenditures. We anticipate moving into additional schools in year two now that we have a program developed to recruit volunteers, work with the school teachers and have the program to assist students fully developed.

Going Forward:

- United Way will fund Reading Tutor Coordinator position to work with school district
- Enhance communication between coordinator and tutors. Further enhance and clarify tutor session information
- Enhance training of tutors to be ongoing rather than just one time
- Create system to manage materials for tutors
- Survey tutors and teachers two times throughout year
- United Way will use the balance of the first year's grant money to fund the second year of operation of the reading tutor program.

-The program we are using is working well (a few "hiccups" but that was expected)


-The feedback I have received from tutors and teachers alike is very positive !!

READING TUTOR PROGRAM 2012-2013 YEAR ONE



PROGRAM DESCRIPTION:

- 1. Sight Words: This is a basic word recognition task. Students have sight word rings. Rings are practiced to commit words to memory.
- 2. Phonics/Phonemic Awareness: This involves practice with letter recognition, letter sound practice and blending words. (done during decodable book read)
- 3. Reading Fluency: The child reads decodable books from book box to the tutor to assist in reading fluency. Child should track words as he/she reads aloud.
- 4. Activities/game; or tutor reads book to child.

PROGRAM NARRATIVE:

- Program began working with students in late October.
- Currently program at Riverbend has 12 tutors who work one on one with a child for 30 minutes, twice weekly. 12 students are served.
- Two children have made significant progress and have already been moved out of the tutor program as they reached grade level. Two other children have moved into those slots.
- Children receive incentives (stickers), and once their chart is complete, earn a book bag.
- Training: Tutors who were not at the initial training have received one on one training from coach.
- Communication: Coach has provided occasional email updates to tutors, as well as a thank you gift during the holiday.
- Appreciation: December: Card/Gift; May: Year End Wrap Up luncheon
- Tutors suggested more ongoing training
- Survey completed by tutors and teachers at end of year

Coeur d'Alene Mines Corporation announced its partnership in United Way's reading tutor program with a donation of \$75,000.

The United Way of Alaska, Coeur d'Alene Mines Corporation and the Juneau School District have partnered on the Volunteer Reading Tutor program to help Juneau youth read at grade level by third grade.

"The contribution we made today is really the easy part of the effort," Wayne Zigarlick, General Manager of Kensington Gold Mine. Volunteer tutors, he said, "those are the ones who will be making a difference."

Coeur, owner of Kensington Gold Mine, announced its contribution to the effort at the Chamber of Commerce lunch lecture series at the Moose Lodge, Thursday.

Glenn Gelbrich superintendent of the Juneau School District said he believes Juneau is the perfect place to create a successful early childhood literacy program. He said he often hears conversations about the success of all of Juneau's citizens.

"We appreciate it every time someone makes a contribution ... by donating time, donating energy and doing as Coeur is doing today, donating serious resources," Gelbrich said, "\$75,000 is no small investment. Our job is now to make sure that that investment pays the highest possible dividend for children."

Coeur's contribution funds the Volunteer Reading Tutor program for three years and brings volunteer tutors into Juneau classrooms to help students reach their reading potential during the important years leading up to their third-grade year.

Children who have trouble reading at grade level often struggle in school and drop out as a result, Mary Becker, chair of United Way, said. While successful readers are likely to graduate on time and are better prepared to enter the work force, she said.

"United Way [of Southeast] places an emphasis on reading success," Becker said. "[It] expects to see graduation rates increase, dropout rates decrease and substance abuse rates decrease."

Without substantial help, poor readers in the third grade are poor readers in the ninth grade, Patty Newman director of teaching and learning for the Juneau School District said.

"Our six year olds, our first graders have a one in eight chance of catching up without extraordinary efforts," Newman said. "Which is what we are all about today, those efforts.

The program is focused on Kindergarten, first and second grade students, Newman said. "Really intervene early."

Volunteers are asked to spend 30 minutes, twice a week in the classroom working with young students who might need extra help with reading skills. Volunteers can count on a teacher in the room, Newman said. An instructional coach will be there to answer question, problem solve, coach and cheerlead, she said.

Tutors will received training to use Reading A to Z a literacy program designed for tutors (<u>www.readinga-</u><u>z.com</u>).

The Volunteer tutor program, organized over the past six months, is scheduled to launch in mid-October.

President and CEO of United Way of Southeast Alaska, Wayne Stevens said the tutor program will supplement existing programs like the Association for the Education of Young Children Dolly Parton's Imagination Library. The library provides books and reading tools for youth, birth to five years old.

"But not every newborn is signed up from the program and not every kindergartener is fully prepared to learn to read," Stevens said. "We're trying to pick up and follow through on those children who are not quite at those levels needed for entry to school."

Stevens said these early childhood reading programs equate to better readers entering school. The first group, birth to five years, enrolled in the library program contributed to a spike of 10 percent in entry-level reading scores of those kindergarteners, he said.



Bylaws of

United Way of Southeast Alaska

ARTICLE 1 -- NAME AND PURPOSE

- Section 1: Name. The name of the organization is United Way of Southeast Alaska. It is a nonprofit 501(C) 3 organization incorporated under the laws of the State of Alaska.
- Section 2: Purpose and Vision. United Way of Southeast Alaska is organized to improve lives and communities in Southeast Alaska. The vision of the organization is to implement a community impact-based United Way program capable of addressing individual needs and improving lives by organizing the caring powers of our communities. To serve this vision, the organization:
 - Partners with business, government, and nonprofit sectors to identify and solve urgent community problems.
 - Partners with United Way member agencies to provide a network of care and community impact.
 - Links donors and volunteers with the issues they care about.

ARTICLE II -- BOARD OF DIRECTORS

- Section 1: Board Role, Size, Composition. The Board is responsible for overall policy and direction of the organization, and delegates responsibility for day-to-day operations to the President and committees. The Board shall have up to 21 and no fewer than seven members. The Board receives no compensation other than reasonable expenses.
- *Section 2:* Meetings. The Board shall meet monthly, at an agreed-upon time and place. An official board meeting requires that each board member receive notice at least one week in advance.
- Section 3: Special Meetings. Special meetings shall be called upon the request of the Chair or one-third of the Board. The notice of any special meeting shall state the purpose(s) of the proposed meeting. Business transacted at all special meetings shall be restricted to those subjects. Special meetings may be conducted in person, by teleconference, or via email.
- *Section 4:* Quorum. The participation in person, by teleconference, or via email of not less than a majority of the voting directors constitutes the quorum necessary for business to be transacted or motions to be made or passed.

Section 5: Executive Sessions. All meetings of the Board will be open to the public, including representatives of recipient agencies. However, the Board may, by two-thirds vote, convene in executive session for a reason stated before convening. The following excepted subjects may be discussed in an executive session:
(1) Matters the immediate knowledge of which would clearly have an

adverse effect on the finances of the corporation;(2) Personnel matters including subjects that tend to prejudice the reputation and character of a person; however, the person may request a

public discussion;(3) Matters discussed with an attorney for the corporation, the immediate knowledge of which could have an adverse effect on the legal position of the corporation.

No official action may be taken in executive session.

- Section 6: Board Elections. Election of directors occurs at the first meeting of the calendar year and shall fill expired terms. A two-thirds majority vote is required to grant Board membership.
- Section 7: Terms of Office. Directors shall be elected to the Board for overlapping three-year terms, and are eligible for re-election. Outgoing board members may elect to serve on United Way committees and task forces.
- Section 8: Vacancies. When a vacancy on the Board exists, nominations for new members may be presented by current Board members at a Board meeting. A director elected to fill a vacancy shall be elected for the unexpired term of his/her predecessor in office. No vacancy shall continue for longer than six months.
- Section 9: Ex-officio Board Members. Four ex-officio members of the Board may be appointed, consisting of the current campaign chair and vice-chair and representatives of two member agencies. Ex-officio members will serve alternating two-year terms to a maximum of six years. One ex-officio member will represent large agencies and the other will represent small agencies. Agency size is determined by gross budget amounts. Large agency shall have a budge of greater than one million, five hundred thousand dollars. Small agency shall have a budget less than one million, five hundred thousand dollars.
- Section 10: Nomination. The Board Development Committee shall invite Board members to recommend candidates for open Board of Director positions. The Board Development Committee shall nominate candidates for Board Directors at the January Board meeting, seeking to preserve the diversity and balance necessary to enable United Way of Southeast Alaska to provide policy guidance on the broad spectrum of community issues. New Directors shall be elected by the Board at the February Board meeting.

Board terms shall be staggered so as to preserve an equal balance of members whose terms will expire in any one year.

- Section 11: Resignation, Termination and Absences. Resignation from the Board must be in writing and received by the Chair. Cause for removal from the Board shall include three consecutive unexcused absences from Board meetings. A Board member may be removed for this and other reasons by a three-fourths vote of all the remaining directors.
- Section 12: Officers and Duties. The officers shall be Chair, Chair-Elect, Secretary and Treasurer, all of whom shall be members of the Board. The Board Development Committee shall nominate a slate of Board officers at the January Board meeting. In addition, any Board member may nominate a candidate for office from the floor at the January meeting. However, to be considered, the nominee must agree to serve the post prior to the Board's vote. The officers shall be elected by the Board at the February Board meeting. All officers shall hold office for one year, at which time their successors will be elected. The Chair-Elect will assume the presidency after one year on the executive committee. The officers' duties are as follows:

The **Chair** shall convene regularly scheduled Board meetings, and shall preside or arrange for other officers to preside at each meeting in the following order: Chair-Elect, Secretary and Treasurer. Together with the President, the Chair shall create the agendas for meetings, shall make appointments to standing committees, and shall perform other duties incidental to the office of Chair.

The **Chair-Elect** shall assume the duties of the Chair during the Chair's absence, shall assist the Chair in the performance of leadership functions, shall chair the Board Development Committee, and shall perform other duties incidental to the office of Chair-Elect.

The **Secretary** shall be responsible for keeping records of Board actions, including overseeing the taking of minutes at all Board meetings, distributing copies of minutes to each Board member, shall chair the Personnel Committee, and shall assure that corporate records are maintained.

The **Treasurer** shall make a report at each Board meeting. The Treasurer shall chair the Finance Committee, assist in the preparation of the budget, and make financial information available to Board members and the public. The Treasurer shall review the audits or independent financial reports of the agency to ensure accuracy.

- Section 13: Officer Vacancies. When a vacancy among the Board officers exists, nominations for new officers may be presented by current Board members at a Board meeting. Candidates must be current members of the Board. Vacancies will be filled to the end of the resigning officer's term.
- Section 14: Bonding. The Board of Directors may require the Treasurer, or any other officer or any employee of the organization to be bonded.

ARTICLE III - COMMITTEES

- Section 1: Committees of the Board: The Board may create committees as needed. There shall be four standing committees: Executive, Finance, Personnel and Board Development. The Board shall, by resolution, establish the membership and duties of each standing committee except the Executive Committee. The Chair may designate and appoint one or more committees, each of which shall consist of two or more directors, which committees, to the extent provided in said resolution, shall have and exercise the authority of the Board in the management of the corporation. No such committee shall have the authority of the Board in reference to amending, altering or repealing the Bylaws; electing, appointing or removing any member of any such committee or any director or officer of the corporation; amending the Articles of Incorporation; restating Articles of Incorporation; adopting a plan of merger or adopting a plan of consolidation with another corporation; authorizing the sale, lease, exchange or mortgage of all or substantially all of the property and assets of the corporation; authorizing the voluntary dissolution of the corporation or revoking proceedings therefore; adopting a plan for the distribution of the assets of the corporation; or amending, altering or repealing any resolution of the Board which by its terms provides that it shall not be amended, altered or repealed by such committee. The designation and appointment of any such committee and the delegation thereto of authority shall not operate to relieve the Board, or any individual Director, of any responsibility imposed upon the Board or any director by law. [AS§10.20.111] All standing committees shall report to the full board at the next regularly scheduled meeting of the board. Any actions taken on behalf of the board by the Executive Committee shall be ratified by the full board at the next regularly scheduled meeting.
- Section 2: Executive Committee: There is established the Executive Committee, composed of the Chair, the Chair-Elect, the immediate Past Chair, the Secretary and Treasurer. The Executive Committee shall have and may, when sitting in quorum composed of a majority of the Executive Committee members, exercise the powers of the Board between meetings of the Board as described in and limited by the preceding paragraphs. Any member of the United Way of Southeast Alaska Board may attend meetings of the Executive Committee.

Nothing herein shall prevent the Executive Committee from entering into an Executive Session and thereby limit attendance in the best interests of the Organization.

- Section 3: Finance Committee. The Treasurer chairs the Finance Committee, which is responsible for developing and reviewing fiscal procedures and the annual budget, with staff and other Board members. The Board must approve the budget, and all expenditures must be within the budget. Any major change in the budget must be approved by the Board. The fiscal year is defined as the twelve month period ending August. The Treasurer will submit monthly reports to the Board. Changes to the budget will be presented to the Board periodically. The financial records of the organization shall be made available to Board members, member agencies and the public.
- Section 4: Personnel Committee. The Secretary chairs the Personnel Committee. The Board as a whole is responsible for hiring the President, who reports to the Chair and Chair-Elect. The President is responsible for hiring and supervising other staff. The Personnel Committee shall operate as a grievance committee, and is responsible for developing a personnel policy.
- Section 5: Board Development Committee. The Chair-Elect chairs the Board Development Committee, which shall be appointed by the Board to represent diverse aspects of the community. Committee members shall serve one-year terms. The committee shall be responsible for developing nominees for board election, board committees, and planning for board training and leadership development.
- Section 6: Other Committees. Other committees not having and exercising the authority of the Board in the management of the corporation may be appointed by the Chair. Except as otherwise provided in such resolution, the Chair of the board shall appoint the members thereof. Any member thereof may be removed, without cause stated, by the person or persons authorized to appoint such member whenever, in the judgment of the appointing authority, the best interests of the corporation shall be served by such removal.

ARTICLE IV -- PRESIDENT AND STAFF

Section 1: President. The President serves as the principal professional resource and fiscal agent appointed and employed by the Board of Directors. The President serves at the pleasure of the Board. Within the framework of the organization's policies and by-laws, the President has the authority to take necessary action to direct the day-to-day operations of UWSEAK, including supervising staff and implementing the organization's goals and

Board policy. The President will attend all Board meetings, report on the progress of the organization, answer questions of Board members, and carry out the duties outlined in the job description. The Board may designate other duties as necessary.

ARTICLE V -- FUNDING POLICIES

Section 1: The Board of Directors reviews and adopts fund distribution policies and guidelines related to member agencies, allocations, and emergency funding. Revisions to these policies require a two-thirds majority vote.

ARTICLE VI -- NONDISCRIMINATION

Section 1: The directors, officers, committee members, volunteers, employees and member agencies of this organization shall be selected entirely on a nondiscriminatory basis with respect to age, gender, race, religion, or national origin.

ARTICLE VII -- AMENDMENTS

Section 1: These Bylaws may be amended when necessary by a two-thirds majority vote of the full Board of Directors. Proposed amendments must be sent out with regular Board announcements.
